Tennsco is tops!

Manufacturers group gives company national award for community service

The National Association of Manufacturers (NAM) has recognized Tennsco Corp. with its top award for community service.

Each year, the national association representing 11,000 large and small manufacturers, honors a NAM member company that has shown exemplary leadership in serving its community or state "and is an example of the giving spirit of the nation's manufacturers and businesses," said a statement from NAM.

President Stuart Speyer, his wife Shirley, and Vice President for Finance Mike Easley were on hand at the national covention in Washington, D.C., to receive the Sandy Trowbridge Award for Excellence in Community Service.

NAM is the preeminent US manufacturers association as well as the nation's largest industrial trade

association, representing small and large manufacturers in every industrial sector and in all 50 states.


"The commitment to community service by Tennsco and its employees truly embodies the legacy of Sandy Trowbridge," said NAM President and CEO Jay Timmons. "Tennsco's volunteerism and service are a great example of the leadership role manufacturers play in their communities."

The Trowbridge Award is named

after the late Alexander B. "Sandy" Trowbridge, former U.S. Secretary of Commerce who served as president of the NAM from 1979 to 1989. Trowbridge was known for his leadership on behalf of manufacturing and for his strong commitment to community service.

Timmons noted that Tennsco employees spend their time volunteering and contributing to the Com-

Toys help make Christmas possible for area children

Tennsco employees opened their hearts and their pocketbooks at Christmas to help the Dickson County Firefights for Kids(DCFFK) gather toys and distribute them to needy children.

Employees located a large box in the Main Office kitchen and filled it with gifts for local children.

DCFFK is a non-profit organization designed to help Dickson County children in various ways. The organization is composed of Dickson County fire department personnel, paid and volunteer, who are dedicated to helping children for the past 15 years. One of DCFFK's largest projects is the Christmas-time gathering of toys. The group works with the Tennessee Department of Children's Services to identify the children. Parents apply for the assistance and must show proof of need.

DCFFK President Julia Holt thanked Tennsco employees for the donated toys. "Tennsco

helped us tremendously. We had another business in Dickson unable to help this year so we were at a standstill."

With Tennsco contributing, it meant the organization could help 325 children in December.

"If it wasn't for businesses such as Tennsco, we wouldn't be able to do as much as we anticipated," Holt said.

DCFFK also helps families who suffer losses in house fires. Whether it's new clothing, shoes, coats, food or even new toys, it is important that children have these things to aid in the healing process after such a loss, Holt stated.

To prevent house fires, DCFFK also places working smoke detectors and/or carbon monoxide detectors in homes throughout the county. Several local companies donate the fire detectors. DCFFK members go into homes and install the devices for families.

DCFFK is not affiliated with Toys for Tots.




